COMPETITION (BLOCK EXEMPTION FOR VESSEL SHARING AGREEMENTS AND  
VOLUNTARY DISCUSSION AGREEMENTS IN RESPECT OF LINER SHIPPING SERVICES)  
(AMENDMENT) ORDER 2017

IN exercise of the powers conferred by subsection 8(1) of the Competition Act 2010 [*Act 712*], the Commission makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Competition (Block Exemption for Vessel Sharing Agreements and Voluntary Discussion Agreements in respect of Liner Shipping Services) (Amendment) Order 2017**.

(2) This Order comes into operation on 7 July 2017.

**Amendment paragraph 4**

2. Paragraph 4 of the Competition (Block Exemption for Vessel Sharing Agreements and Voluntary Discussion Agreements in respect of Liner Shipping Services) Order 2014 [*P.U. (A) 195/2014*] is amended by substituting for the word “three” the word “five”.
