



### **Malaysia Competition Commission (MyCC)**

The Malaysia Competition Commission (MyCC) is an independent body established under the Competition Commission Act 2010 to enforce the Competition Act 2010. The Competition Act and the Competition Commission Act were gazetted on 10 June 2010 and enforced beginning 1 January 2012. The acts aimed to encourage national economic development by encouraging and protecting the competition process in the market and consequently protecting consumer interests.

### **Commission's Main Functions**

The Competition Commission Act 2010 empowers the Malaysia Competition Commission (MyCC) to carry out functions such as implement and enforce the provisions of the Competition Act 2010, issue guidelines in relation to the implementation and enforcement of the competition laws, act as an advocate for competition matters; carry out general studies in relation to issues connected with competition in the Malaysian economy or particular sectors of the Malaysian economy; inform and educate the public regarding the ways in which competition may benefit consumers in, and the economy of, Malaysia.

### **GENERAL ELIGIBILITY CRITERIA**

1. Must be a Malaysian citizen; and
2. Must be at least 18 years of age as of the closing date of the job advertisement.

### **QUALIFICATION REQUIREMENT FOR THE MALAY LANGUAGE**

1. Must possess an excellence (at least Grade C) in the Malay Language subject at the level of the Malaysian Certificate of Education / Malaysian Vocational Certificate, or any qualification duly recognized by the Government.

### APPLICATION PROCEDURE

- Applications must be submitted through the official website of the Malaysia Competition Commission (MyCC) at [www.mycc.gov.my](http://www.mycc.gov.my).
- Each application form must be accompanied by a formal passport-sized photograph and certified copies of the following documents:
  - National Identity Card;
  - Diploma/Degree along with the Transcripts and a Letter of Degree/Diploma Recognition from the Malaysian Qualifications Agency (MQA) or the Public Services Department (JPA);
  - School leaving certificate;
  - Certificates such as PMR, SPM, STPM; and
  - Other relevant certificates.
- Incomplete or non-compliant application forms will not be considered. As an example, failure to include a photograph will render the application incomplete.
- The salary offered will be determined based on academic qualifications, experience, and other conditions specified by the Government and is non-negotiable. No negotiations will be entertained.
- The application deadline is **15<sup>TH</sup> JUNE 2025**.

**MANAGEMENT AND PROFESSIONAL GROUP**

**1) DIRECTOR, INVESTIGATION AND ENFORCEMENT DIVISION, GRADE E14**

1. Candidates applying for the position must possess the following qualifications:

- i. Bachelor's degree with honors or Master's degree in Economics/Law or related fields recognized by the Government, or equivalent qualification;
- or
- ii. An Honors Bachelor's Degree recognized by the Government from local institutions of higher education or an equivalent qualification.

2. Additional Requirements:

- a. Candidates must have **at least 15 years of working experience** in the field of investigation and enforcement or other related areas. Preference will be given to candidates with knowledge of competition policies and laws, either in Malaysia or at the international level;
- b. Possess knowledge of government policies, including experience dealing with government departments and agencies;
- c. Excellent writing and communication skills in both Bahasa Malaysia and English; proficiency in a third language is an added advantage;
- d. Strong analytical and problem-solving skills; and
- e. Proven leadership skills and the ability to build good relationships with stakeholders at various levels.

In addition to the required relevant experience and mass communication knowledge, candidates should portray of the following:

- Committed and dedicated to organizational goals and objectives;
- Strong interpersonal skills such as negotiating, problem-solving, and knowledge-sharing; and
- Ability to work under pressure with the right attitude, strong integrity, upholds teamwork principle, highly resilient with professional character.

## **Core Responsibilities:**

- a. Responsible for formulating and managing policies and planning related to exemptions, leniency regimes, investigations, and enforcement of anti-competition laws;
- b. Responsible for managing the preparation and implementation of procedures for exemptions, leniency regimes, intelligence gathering, investigations, and the handling of investigation papers and evidence;
- c. Responsible for managing the implementation of exemption policies, leniency regimes, intelligence gathering, investigations, and reporting in accordance with established guidelines and procedures;
- d. Responsible for handling exemption and leniency procedures and making recommendations accordingly;
- e. Responsible for managing the planning of intelligence operations, and the collection of information and data regarding anti-competitive practices;
- f. Responsible for managing the review and analysis of reports following intelligence operations;
- g. Responsible for managing the planning of raids and investigations;
- h. Responsible for managing the execution of raids and investigations into violations of the Competition Act 2010 and related criminal offences;
- i. Responsible for managing the opening and maintenance of investigation papers and the evidence obtained;
- j. Responsible for managing the preparation of reports on exemption applications, leniency eligibility, and investigations into violations or criminal offences;
- k. Responsible for managing the preparation of investigation outcomes related to exemption applications, leniency eligibility, and violations or offences, and for providing input for upper management's awareness;
- l. Responsible for managing the security of information derived from intelligence and investigation outcomes;
- m. Responsible for supervising the implementation of directives, interim measures, report preparation, and providing input on cases decided by the Commission, as well as the execution of the Commission's decisions on violations of the Competition Act 2010 and the enforcement of undertakings;
- n. Responsible for overseeing the maintenance of records of the Commission's case decisions, compound cases, and court prosecutions;
- o. Responsible for conducting training related to the enforcement of directives, decisions, and interim measures;

- p. Responsible for managing or supervising all work related to the Investigation & Enforcement Division; and
- q. Perform any ad-hoc tasks assigned by Management or the Chief Executive Officer from time to time.
