



Malaysia Competition Commission (MyCC)

The Malaysia Competition Commission (MyCC) is an independent body established under the Competition Commission Act 2010 to enforce the Competition Act 2010. The Competition Act and the Competition Commission Act were gazetted on 10 June 2010 and enforced beginning 1 January 2012. The acts aimed to encourage national economic development by encouraging and protecting the competition process in the market and consequently protecting consumer interests.

Commission's Main Functions

The Competition Commission Act 2010 empowers the Malaysia Competition Commission (MyCC) to carry out functions such as implement and enforce the provisions of the Competition Act 2010, issue guidelines in relation to the implementation and enforcement of the competition laws, act as an advocate for competition matters; carry out general studies in relation to issues connected with competition in the Malaysian economy or particular sectors of the Malaysian economy; inform and educate the public regarding the ways in which competition may benefit consumers in, and the economy of, Malaysia.

The MyCC is inviting dedicated and committed candidates with high integrity and professionals to join us. Please note that applicant must be a MALAYSIAN CITIZEN and the position offered is on a CONTRACT basis:

GENERAL ELIGIBILITY CRITERIA

1. Must be a Malaysian citizen; and
2. Must be at least 18 years of age as of the closing date of the job advertisement.

QUALIFICATION REQUIREMENT FOR THE MALAY LANGUAGE

1. Must possess an excellence (at least Grade C) in the Malay Language subject at the level of the Malaysian Certificate of Education / Malaysian Vocational Certificate, or any qualification duly recognized by the Government.

APPLICATION PROCEDURE

- Applications must be submitted through the official website of the Malaysia Competition Commission (MyCC) at www.mycc.gov.my.
- Each application form must be accompanied by a formal passport-sized photograph and certified copies of the following documents:
 - National Identity Card;
 - Diploma/Degree along with the Transcripts and a Letter of Degree/Diploma Recognition from the Malaysian Qualifications Agency (MQA) or the Public Services Department (JPA);
 - School leaving certificate;
 - Certificates such as PMR, SPM, STPM; and
 - Other relevant certificates.
- Incomplete or non-compliant application forms will not be considered. As an example, failure to include a photograph will render the application incomplete.
- The salary offered will be determined based on academic qualifications, experience, and other conditions specified by the Government and is non-negotiable. No negotiations will be entertained.
- The application deadline is **15TH JUNE 2025**.

MANAGEMENT AND PROFESSIONAL GROUP

1) PRINCIPAL ASSISTANT DIRECTOR, LAW AMENDMENT AND INTERIM MERGER UNIT, E12

1. Candidates applying for the position must possess a Bachelor's Degree with Honours in Economics or Law recognized by the Government or a qualification recognized as equivalent

2. Additional Requirements:

- a. Candidates must have **at least 10 years of working experience** in the field of economics or law. Preference will be given to candidates with knowledge of competition policies and laws, either in Malaysia or at the international level;
- b. Possess knowledge of government policies, including experience in dealing with government departments and agencies;
- c. Excellent writing and communication skills in both Bahasa Malaysia and English; proficiency in a third language is an added advantage;
- d. Strong analytical and problem-solving skills; and
- e. Demonstrated leadership skills and the ability to build good relationships with stakeholders at various levels.

In addition to experience and knowledge in the field of law, candidates must possess the following characteristics:

- Demonstrated strong commitment to achieving the goals and objectives of the organization;
- Good interpersonal skills in conducting negotiations, problem-solving, and knowledge sharing; and
- The ability to work under pressure, high integrity, and a strong commitment to teamwork principles.

Core Responsibilities:

- a. Finalize amendments to guidelines and Standard Operating Procedures (SOPs) in alignment with the amendments to the Competition Act 2010 and the Competition Commission Act 2010, which are expected to be finalized by March 2025;
- b. Serve as the focal point and lead the integration process of the Merger Control Regime with merger laws under the jurisdiction of relevant sectoral regulators or agencies;
- c. Conduct comprehensive assessments of merger transactions filed with MyCC within a 120-day period to determine whether they may have adverse effects on consumers and market competition;
- d. Investigate merger transactions that are expected to cause negative impacts on competition or violate MyCC's prescribed merger procedures;
- e. Hold pre-notification discussions with involved parties and provide full guidance on upcoming merger notifications;
- f. Manage and resolve all complaints/inquiries and ministerial directives related to merger transactions in Malaysia;
- g. Conduct market intelligence on merger transactions in Malaysia or abroad that may impact the Malaysian market;
- h. Assess and periodically review market conditions relating to the implementation of commitments by parties involved in mergers;
- i. Develop and update the status of assessments or investigations of merger transactions filed with MyCC;
- j. Responsible for managing reports and providing periodic updates to the Ministry, Commission Members, and the Merger Transaction Evaluation Committee; and
- k. Perform any ad-hoc tasks assigned by Management or the Chief Executive Officer from time to time.
