Leniency Program

Introduce leniency program in 2011

Full immunity (First apply for leniency before TFTC	Reduction (apply for leniency after TFTC initials investigation)			
initials investigation)	1	2	3	4
100% immunity	30%~50%	20%~30%	10%~20%	<10%
Marker system: gather the required information and evidence within a specific period.	-	-	-	-

- Conditional consent, applicants shall follow,
- Withdraw from concerted action immediately
- Follow the instructions of the CTFTC
- Provide evidence
- Give a general understanding of the facts of the concerted action
- Shall not disclose to any other parties about filling the application before the case is concluded

When the case is concluded, the applicants who comply with "conditional consent" shall grant full immunity or reduction.

Investigation procedure & Leniency

Leniency application

 One company applied for immunity in accordance of with the "Regulations on Immunity and Reduction of Fines in Illegal Concerted Action Cases"

• At the same time, this company sent application to other authorities, such as Canada, US, EU, Japan, Korea, Brazil, Singapore, China, Mexico

Initialed investigation and assessment

- Encouraged potential applicants to apply for leniency
- Examined the evidence provided by the leniency applicants, then issued a "conditional consent" to them

In-depth investigation

- •The applicants shall follow the instruction of CTFTC,
 - •Give the understanding of this concerted action
 - Provide information, document, evidence...

Evaluation and administrative penalty

- First leniency applicant was granted full immunity
- Others was granted reduction of fines according to their application order




Market Structure

The involved companies are the main producers in this market.



Mutual Understanding Content

- Since 2005....
 - Exchange sensitive business information, such as prices, quantity, capacity, terms of trade to reach agreements
 - The conducts were sufficient to affect the market function of capacitors in Chinese Taipei.



Impacts on Market of Chinese Taipei



Aluminum Capacitors

- Total sales revenue from involved companies > NTD 50 billion
- Main customers from Chinese Taipei, such as Delta, Liteon, Foxconn.
- Chinese Taipei's companies are far smaller than these Japanese companies.

Tantalum Capacitors

- Total sales revenue from involved companies > NTD 16 billion
- Main customers from Chinese Taipei, such as Foxconn, Wistron, Compal, Quanta.
- In Chinese Taipei, all tantalum capacitors are fully imported.

A direct, substantial impact on the Chinese Taipei market with reasonably foreseeable effects

Key benchmarks

Leniency Program

• This is the first case which was deemed as serious violation of concerted action since leniency program was introduced.

International Cooperation

- •International cooperation with US(DOJ), EU(EC), Japan(JFTC), Singapore(CCS)→investigation actions were taken on March 28, 2014 simultaneously.
- Exchanged information with these authorities

First and Efficiency

- CTFTC was the first competition authority to make decision.
- •JFTC made decision on 29 March 2016.

Surcharge

- Serious violation of concerted action→10% of worldwide turnover of the previous year
- Surcharge of this case is the highest for international business since the establishment of CTFTC

Challenges during Investigation

The Service of Investigation Letter

 Most alleging companies are foreign companies. In the beginning of the investigation, the letter of investigation were served by missions abroad or forwarded by foreign subsidiaries in Chinese Taipei.

Great Complexity

•There are 17 companies involved and 4 multilateral meetings. The duration of involving in cartel activities and the number of attending meetings for each member are different.

Huge pile of Documents

•There is a huge pile of business documents during 2005 to 2014. Furthermore, since deposition statements or evidences were in Japanese or English, it took time to translate into Chinese.

Points of Breakthrough

International Cooperation

• Close cooperation among competition agencies, especially US(DOJ), EU(EC), Japan(JFTC) and Singapore(CCS).

Leniency Application

• Involved companies were encouraged to be leniency applicants.

E-Documents

• The CTFTC asked involved companies to provide e-documents, including, inter alia, statements, meeting records, e-mails and memos.
