  - (iii) direct and ensure that the Central Committee Members of the PMLOA do not engage in any anti-competitive conduct in the future.

- 4) The Central Committee Members of the PMLOA shall use the following exact wordings and sentences for the announcement and the Central Committee Members of the PMLOA must ensure that the translation of the announcement into Bahasa Malaysia, Chinese and Tamil is accurate. Failure to ensure the accuracy of the translation will result in the republication of announcement at the Central Committee Members of PMLOA's own cost.

#### **ANNOUNCEMENT OF APOLOGY**

TAKE NOTICE THAT we, the Central Committee Members of PAN MALAYSIA LORRY OWNERS' ASSOCIATION (PMLOA) hereby tender an apology for our decision to fix transport charges in Malaysia by up to fifteen percent (15%). We fully accept that such decision has or is likely to infringe Section 4(2)(a) of Competition Act 2010. This decision was the result from a series of actions that took place between 5 and 11 September 2013 which was then announced in the Star newspaper on 11 September 2013.

TAKE FURTHER NOTICE THAT we, the Central Committee Members of PMLOA had rescinded the said decision on 25 September 2013 with immediate effect and thereafter had directed all the members of PMLOA to cease and desist from further implementing the decision. In addition, the Central Committee Members of PMLOA and all PMLOA's members hereby give an undertaking not to engage into any anti-competitive conduct in the future and shall ensure that its members comply with the Competition Act 2010 at all times.

Finally, we, the Central Committee Members of PMLOA hereby urge all enterprises in Malaysia not to engage into any anti-competitive behaviour and shall always ensure compliance with the Competition Act 2010.
